- 1.1 All medical teachers must process a postgraduate degree or equivalent qualification included in any one of the Indian Medical Council Act, 1956 (102 or 1956) and National Medical Commission Act, 2019. They must also be registered in a State Medical Register OR National Medical Register, expect in the case of teachers with non-medical Qualifications.
