METHOD OF SELECTION

The Entrance Examination will be of total 100 marks (Part -A, 60 marks & Part-B, 40 marks)

Part - A

An objective-type, written examination of 90 minutes duration, consisting of 60 multiple TRUE/FALSE questions (General Medical Questions). Each question will have a stem and five responses. The candidate is required to mark each response as either true or false. All questions carry equal marks. For each correctly-marked response, 0.2 marks will be awarded. For each incorrectly-marked response, 0.1 marks will be deducted. No marks will be awarded if a response is not marked as either true or false.

In case of tie, i.e in the event of two candidates securing identical total marks, the candidate with higher marks in Part B will be ranked higher and if marks in Part B are also identical then the older (Higher Age) candidatewill be ranked higher.

Only the candidates qualifying for part A will be considered for final merit

Details for Part B

- 1. The question paper is of 40 marks of 30 minutes duration.
- 2. The question paper will consist of 20 question (clinical vignettes related to the subject). Each of the incomplete statement or questions are followed by 4 suggested completions or answers.
- 3. All questions have only one correct response,

Each question carries 2 marks. With No NEGATIVE MARKING

Each question has 4 options.

Each question will have only one correct response.

No marks will be awarded if the candidate has not attempted the said question.

STEPS AFTER SELECTION

Medical examination

No candidate will be permitted to join a course, unless declared medically fit by the Medical Board as constituted by the Institute for the purpose. The decision of the Board shall be final. Withholding information about current or past illness / treatment if discovered at a subsequent stage may result in appropriate disciplinary action that may include termination of appointment at any stage.

Joining

If a candidate fails to join the PDCC Courses by the date stipulated in the appointment /selection letter, the offer shall automatically stand cancelled and the seat will be offered to candidates in the waiting list in order of merit.

Duties and responsibilities

Students admitted to PDCC courses shall simultaneously work as Senior Residents. They will be required to perform such work as may be assigned to them and is necessary in the interest of patient care, teaching, training, research and in emergency services as and when required.

Duration of appointment


All PDCC students are appointed for a maximum period of 1 year. If a PDCC student takes extra- ordinary leave or maternity leave for more than 3 months, the tenure of training will be extended by another six months and examination will be delayed as per the Institute rules in force from time to time. Appointment of PDCC student is for one year. Since the total tenure of SR(HS) is 3 years, (including any previous appointments as SR at KSSSCI or elsewhere, the candidates are required to declare the period of training or service undertaken as Senior Resident at KSSSCI or in other Institutions at the time of applying. Any failure to do so can lead to cancellation of candidature and even termination of appointment.

MISCELLANEOUS INSTRUCTIONS

- The date, time and venue of examination will be provided on the admit card.
- No TA/DA shall be paid for appearing in the entrance examination or for joining.
- Number of seats/posts indicated in the advertisement for the courses programs is provisional and subject to change without prior notice.
- Any attempt on the part of a candidate to suppress facts, to provide false information or to influence selection directly or indirectly will be treated as a disqualification. If evidence of this surfaces after selection, the services may be terminated and admission cancelled, even at that stage.
