## **Final Merit List:**

The final merit list will be prepared based on the marks obtained in the Computer Based Test (CBT) only for all categories (i.e., GENERAL, OBC, SC, ST, EWS, etc.) separately and rank will be awarded to all qualified applicants. While preparing the merit list for the General category, all applicants (including those from the reserved categories) will be taken into consideration, but while preparing the merit list for a reserved category, only applicants of that category will be taken into consideration. The same method will be applicable in all reserved categories.

## **Resolution of Tie:**

Tie breaking Rules will be as follows

1. Total marks of the tied Candidates
2. Date of birth of the tied Candidates. (Older candidate shall be placed higher on the merit list)
3. Number of wrong answers/ negative marks of the tied candidates. (Candidates with lesser number of wrong answers/ negative marks shall be placed higher on the merit list)
4. Total marks in the 'core' section of the examination conducted. (Candidates with higher marks in the core section shall be placed higher on the merit list)
  - a. (for e.g., in the examination referred to above 60% questions pertained to the core subject Syllabus)
  - b. ('core' section would be defined by the Examination Cell of KSSSCI, for each exam, as needed)
5. Application number of the candidate. (Earlier application number shall be placed higher on the merit list)
