The Kalyan Singh Super-Specialty Cancer Institute is an autonomous Institute of the Government of Uttar Pradesh. It is envisioned as a state-of-the-art cancer treatment facility, and is slated to offer a complete range of clinical services for cancer patients, including end-of-life care, under one roof. It will also train doctors in various broad specialties and super-specialties; offer senior resident and post-doctoral certificate / fellowship positions; train nurses and paramedical staff; and focus on innovation and research aimed at providing cost-effective and value-based strategies for the diagnosis and management of cancer patients.

We are looking for CMO, who can leverage information technology tools in their daily work; are team players; and demonstrate reasonable bi-lingual (English and Hindi) communication skills and empathy. The positions will be full time and private practice of every kind is prohibited.

The Institute is committed towards making medical care safe and in improving the most important goals of a person afflicted with cancer - of living longer and better. The treatment decisions would thus be necessarily made through multidisciplinary disease management groups or interest groups, functioning in virtual or real time, and not by individual consultants. This will be accompanied by periodic and systematic audits. These audits shall be the cornerstone of patient care activities at the Institution and will guide changes in various processes to make clinical care more effective, safe and convenient to patients. These will also be a critical parameter for employee / trainee appraisals.

The institution will encourage the CMO to engage and collaborate with civil society, other educational institutions and universities, philanthropic groups, and not-for-profit-organizations, for promoting the cause of evidence-based, comprehensive patient care with a societal perspective and relevant research.

Essential qualifications for Casualty Medical Officer (CMO)

Sr. No.	Post	<u>Essential qualifications</u>
1	Casualty Medical Officer	M.B.B.S. degree of a university recognized by the National Medical Commission (NMC) and having successfully completed compulsory one year of rotatory internship and registered with the National Medical Commission (Central or State) by the last date of submission of the application. Desirable- Post graduate degree/Diploma preferably in (Anaesthesia, Emergency Medicine, General Medicine, Pediatrics, Palliative Medicine, Respiratory Medicine , General Surgery, Orthopaedics, ENT).

Detailed Essential Qualification are as under:

- I. Essential qualification must be completed by the last date of submission of the online application form.
- II. **Pay & Pay Scales:** 7th pay commission as per U.P state Govt.

CMO (Casualty Medical Officer): The pay matrix Level-10 with rationalized entry pay of ₹56,100/- as per 7th pay scale (Pre-revised PB-3, & ₹15600-₹39100/- + Grade Pay of ₹5400/- as per 6th pay scale).

In addition, applicable non-practicing allowance (to clinically-qualified candidates) and other allowances as per the Institute rules will be paid. New pension scheme (NPS) of the government will be applicable.

III. Maximum Age Limit: -

1. Casualty Medical Officer - Not exceeding 40 (Forty) years as on the last date of the submission of online application form.
 - (i) Upper age limit shall be determined as on last date of submission of online application form.
 - (ii) Age relaxation permissible to various categories is as under: -

Sr. No.	Category	Age Relaxation permissible beyond the upper age limit
1.	SC/ST	05 Years
2.	PwBD	05 Years

2. Government servants and candidates belonging to scheduled castes /scheduled tribes/ other backward class will get age relaxation as per Uttar Pradesh Govt. rules /orders.
3. Age relaxation to other categories will also be applicable as per the DoPT/ UP state Govt. instructions.
4. In case of women candidates, the Caste Certificate of a person is to be decided on the basis of her birth in the said community as per UP government rules.
5. Scheduled Caste, Scheduled Tribes, Other Backward Class, Dependents of Freedom Fighter, and Persons with Disability, Ex-Serviceman and women candidates who are not the permanent residents of Uttar Pradesh shall not be given the benefit of reservation/age relaxation. Such candidates shall be treated as the candidates of the General Category and should apply in General Category.

General conditions:

- Aspiring applicants must fulfil all essential eligibility criteria, educational qualification, age limit, etc. as per instructions (see Table 2) and submit their ONLINE application only. On-line application link will be available on KSSSCI, Lucknow websites <https://cancerinstitute.edu.in>.
- No application/fee will be accepted after last date of submission of application form.
- The applicant must ensure that the transaction of payment is done by the Bank. In case of reversal of payment/incomplete payment/charge back of payment, the candidature will be cancelled at any stage of examination. The duplicate fee will not be refunded. Candidate can also amend his application form except -Registered Mobile Number, Email, Aadhar Number, Category, etc.
- Incomplete applications will not be considered and will be rejected.
- Those in service must append a 'No-objection certificate' from the current employer.

- A Non-refundable application fee of Rs. 1000 for SC domiciled in the state of Uttar Pradesh, needs to be paid online before the application form can be filled.
- The horizontal reservation in respect of above posts will be decided as per existing provisions.
- Biometric/ Iris Identification is must before the written exam and the same will be verified once the candidates joined the institute.
- The appointment shall be subject to certification of medical fitness by the Medical Board of Institute /Authorized Medical board.
- Candidates with valid application shall be issued admit card. These can be downloaded by candidates directly from Institute's website <https://cancerinstitute.edu.in> by entering their registration number / application number, Date of birth.
- Selection/Appointment of the candidate for the post is purely provisional, unless Verification of documents and genuineness of the candidature is verified. In case of any Incorrect/ falsification/ tempered/fabrication found, selection/appointment will be liable to be cancelled forthwith and appropriate Legal action may be taken against the candidate.
- Number of posts/positions may increase/decrease as per the decision of the Director KSSSCI.
- In case of any discrepancy in print media or website, the records with KSSSCI, Lucknow will be treated as final.

- d) Scanned Image of Caste/Category and Sub- Category (if applicable), Domicile Certificate (if applicable) & Experience Certificate (if applicable) (file size less than 800 KB)**

A valid E-mail id and Mobile Number is mandatory for the submission of your Online Application. This E-Mail id and Mobile number should be active till the completion of recruitment process.
